

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://SimpleIFTA.com/> and Simple IFTA and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Simple IFTA include Triesten Technologies, LLC., <https://SimpleIFTA.com/> and Simple IFTA. The Simple IFTA website is an IFTA Tax Return site. By using the Simple IFTA website, you consent to the data practices described in this statement.

Collection of your Personal Information

Simple IFTA may collect personally identifiable information, such as your:

- Name
- Business Details
- Address
- E-mail Address
- Phone Number

If you purchase Simple IFTA's products and services, we use Payment Gateway for billing and credit card information. This information is used to complete the purchase transaction.

Simple IFTA encourages you to review the privacy statements of websites you choose to link to from Simple IFTA so that you can understand how those websites collect, use, and share your information. Simple IFTA is not responsible for the privacy statements or other content on websites outside of the Simple IFTA website.

Use of your Personal Information

Simple IFTA collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Simple IFTA may also use your personally identifiable information to inform you of other products or services available from Simple IFTA and its affiliates. Simple IFTA may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Simple IFTA does not sell, rent, or lease its customer lists to third parties.

Simple IFTA may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Simple IFTA, and they are required to maintain the confidentiality of your information.

Simple IFTA will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Simple IFTA or the site; (b) protect and defend the rights or property of Simple IFTA; and, (c) act under exigent circumstances to protect the personal safety of users of Simple IFTA, or the public.

Security of your Personal Information

Simple IFTA secures your personal information from unauthorized access, use, or disclosure. Simple IFTA uses the following methods for this purpose:

- SSL Protocol

When personal information (such as a credit card number) is transmitted to other websites, it is protected using encryption, such as the Secure Sockets Layer (SSL) protocol.

Login credentials and Password

Users are the authorized person to use their respective account by using their login credentials. Users are responsible for using our Software service under your login credentials. You shall not permit or allow other persons to have access to or use your user login credentials and password, except if you choose to provide that information to Simple IFTA authorized technical support personnel to assist you. If you have not electronically filed or printed your tax return, you must create a user ID and password for you to access your tax data at a later date. You must remember your user ID and password to electronically transfer your tax return for the following year should you choose to use the Software again.

Accuracy

We endeavor to collect accurate, complete, and current information to fulfill the requirements of the specified purposes- to file your IFTA tax returns. We do not update your personal information systematically, so we rely on you to inform us of any changes. The specified collection purposes do not require us to update systematically.
